6 - 8 and EOCs will be computer-based

All computer based subparts of ELA 6 to ELA 8, Eng 1, and Eng 2 must be completed no later than April 21, 2023.

All remaining computer-based assessments must be completed no later than Friday May 5, 2023

Any paper-based English 1 and English 2 must completed and ready for pick up on April, 20, 2023

Any remaining paper-based subparts for EOCs must be completed and ready for pickup on Monday May 1, 2023

Testing times for each subpart are listed below.

The times listed are full testing times but do not include preparing for and collection of tests.

If requested by a parent or student, a test administrator may allow a student additional time as listed on the schedules below.

When preparing schedules ensure to permit additional time for additional time and testing logistics

Additional considerations:

Students completing a computer-based assessment may use a hand-held in conjunction with the calculator imbedded in the test When students use a hand-held calculator throughout the school year it is best-practice to permit the use of the same calculator on the TCAP.

When preparing schedules you will want to consider the availability of calculators used in math and science classes Subpart 1 of all math TCAP assessments is non-calculator.

Federal law requires a minimum 95.00% participation rate for all TCAP EOC, MSAA, and ALT assessments.

To count as participated there must be a valid score available for the assessment.

*Note to HS: ACT also requires 95% participation rate based on receiving a college reportable score.
